FY26 Membership Dues Collection Process

The FY26 National Dues Year opens April 1, kicking off the (FY26) membership dues collection process for AAUW branches.

FY26 National Dues: As of April 1 are \$74 (National), \$18.81 (Students), \$1,480 (Lifetime). Fully tax-deductible.

Dues Disbursements: Funds from members who pay online are deposited at the end of the following month via ACH to the state/branch bank accounts. Check your email for disbursement report from infosf@aauw.org at the end of the month. Email connect@aauw.org for bank info updates.

Renewal Notice Reminders: Branches that have not opted out to have National send renewal reminder emails, will be sent to members during the week of the 20th of each month in conjunction with the schedule below. Finance officers receive confirmations as members pay online.

Discounts and Waivers - Coupon Codes

The Shape the Future Campaign discount of 50% off national dues for new members (those entirely new to AAUW or rejoining after having lapsed for two or more years) remains in effect. The coupon code for FY26 effective 4/1 will be STFFY26. The FY26 coupon codes for AAUW College/University member students are CUStudentFY26 for Student Associates (undergraduates) and CUGradStudentFY26 for Graduate Students effective 4/1.

AAUW National Elections 2025 Opens April 14

Voting opens on April 14 noon, ET. Members will receive an electronic ballot with their unique voting credentials from vote@simplyvoting.com, our third-party voting service. Add this email address to your safe sender list to ensure your ballot reaches you. Members without an email address on file will receive a paper ballot. Eligible voters are those who were members as of March 14, 2025. Voting closes on May 13, 5pm ET.

We recently completed this year's honorary upgrades for members with 50 years of membership. Letters and certificates will be sent in April to branch President/Administrators, Membership VPs, and Finance Officers. If you have

- 3. Click the button next to your affiliate name
- 4. Select STATE or BRANCH COMMITTEE
- 5. Follow the on-screen instructions

Community Hub Spotlights

A member's **Join On** date may update if:

• They **rejoin** after a lapse

- A **new account** is created for them
- You use **Join Individuals** to renew an existing member

Action needed: Check the Join On column in your exported roster. If you spot any unexpected changes, notify National.

Using Join Individuals? You can process up to 4 members (new, lapsed, or transfers) in one transaction — as long as they're all paying the same rate.

<u>Finance Officers Must Respond — Don't Lose Your Tax-Exempt Status</u>

All AAUW-affiliated entities must file an annual IRS return. If your gross receipts are \$50K or less, AAUW can file the 990-N for the tax year ending 6/30/2025. Submit the group exemption from April 16 – October 15.

How:

- 1. Log in to Community Hub
- 2. Go to MY AFFILIATIONS
- 3. Click the button next to your affiliate name
- 4. Select TAX INFORMATION → ADD NEW TAX DETAILS
 - a. Principal officer = Finance Officer

Important Note: If you do not qualify to file the 990-N, explore other options (e.g., 990, 990EZ, or 990PF) at <u>irs.gov</u>. Watch <u>990N Request Video!</u>
